

WARRANTY COVERAGE

The AIRSCREEN Company GmbH & Co. KG in Germany ("AIRSCREEN") warrants the AIRSCREEN products against defects in materials and workmanship for a period of two (2) years from the date of original purchase ("warranty period").

If a defect arises and a valid claim is received by AIRSCREEN or its authorized distributors/dealers within the warranty period, at its option, AIRSCREEN will (1) repair the product at no charge, using the new or refurbished replacement parts, (2) exchange the product with a product that is new or which has been manufactured from new or serviceable used parts and is at least functionally equivalent to the original product, or (3) refund the purchase price of the product.

AIRSCREEN warrants replacement products or parts provided under this warranty against defects in materials and workmanship from the date of the replacement or repair for the remaining portion of the original product's warranty.

When a product or part is exchanged, any replacement item becomes the property of the customer and the replaced item becomes AIRSCREEN's property.

Exclusions and limitations

This limited warranty applies only to the products manufactured by or for AIRSCREEN. This limited warranty does not apply to any non-AIRSCREEN products, even if packaged or sold with the AIRSCREEN product. Non-AIRSCREEN manufacturers, suppliers provide a separate warranty for their own products.

AIRSCREEN reserves the right to change the method by which AIRSCREEN may provide warranty service to you, and your AIRSCREEN product's eligibility to receive a particular method of service. Service will be limited to the options available in the country where service is requested. Service options, parts availability and response times may vary according to country. You may be responsible for shipping and handling charges if the AIRSCREEN product cannot be serviced in the country it is in. If you seek service in a country that is not the original country of purchase, you will comply with all applicable import and export laws and regulations and be responsible for all custom duties, V.A.T. and other associated taxes and charges. Where international service is available, AIRSCREEN may repair or replace AIRSCREEN products and parts with comparable AIRSCREEN products and parts that comply with local standards.

AIRSCREEN is not liable for any damage to or loss not covered by this warranty.

This warranty does not apply: (a) to damage caused by accident, abuse, misuse, misapplication or non AIRSCREEN products; (b) to damage caused by service performed by anyone other than AIRSCREEN or its authorized dealers and distributors; (c) to a product or a part that has been modified without the written permission of AIRSCREEN; or (d) if any AIRSCREEN serial number has been removed or defaced.

To the maximum extent permitted by law, this warranty and the remedies set forth above are exclusive and in lieu of all other warranties, remedies and conditions, whether oral or written, express or implied. AIRSCREEN specifically disclaims any all implied warranties, including, without limitation, warranties of merchantability and fitness for a particular purpose. If AIRSCREEN cannot lawfully disclaim or exclude implied warranties under applicable law, then to the extent possible any claims under such implied warranties shall expire on expiration of the warrant period.

To the maximum extent permitted by law, AIRSCREEN is not responsible for direct, special, incidental or consequential damages resulting from any breach of warranty or condition, or under any other legal theory. For consumers who have the benefit of consumer protection laws or regulations in their country of purchase or, if different, their country of residence, the benefits conferred by this warranty are in addition to all rights and remedies conveyed by such consumer protection laws and regulations. To the extent that liability under such consumer protection laws and regulations may be limited, AIRSCREEN's liability is limited, at its sole option to replacement or repair of the product or supply of the repair service again.
